CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of WELLS 1, 2 & 3 IN THE COLUMBIA RIVER BASIN, for the purpose of IRRIGATING 118.5 ACRES.

The right has been perfected under Permit U-184. The date of priority is JUNE 6, 1946. The right is limited to not more than 1.98 CUBIC FEET PER SECOND; BEING 0.66 CFS FROM EACH WELL or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

NE 1/4 NE 1/4, AS PROJECTED WITHIN DLC 41, NE 1/4 SE 1/4, AS PROJECTED WITHIN DLC 43, SECTION 32, T 2 N, R 13 E, W.M.; WELL 1 - 400 FEET SOUTH & 350 FEET WEST; WELL 2 - 350 FEET SOUTH & 400 FEET WEST; WELL 3 - 2350 FEET NORTH & 920 FEET WEST ALL FROM E1/4 CORNER SECTION 32.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-SIXTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
