CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JOHN F. WALCHLI  
ROUTE 3, BOX 3342  
HERMISTON, OREGON 97838

confirms the right to use the waters of AN UNNAMED STREAM AND WALCHLI RESERVOIR CONSTRUCTED UNDER PERMIT R-6575, tributaries of COLUMBIA RIVER, for the purpose of IRRIGATION OF 43.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 727.7 ACRES.

The right has been perfected under Permit 41516. The date of priority is NOVEMBER 8, 1976. The right is limited to not more than 1.08 CUBIC FEET PER SECOND FROM AN UNNAMED STREAM AND 181.5 ACRE-FEET FROM WALCHLI RESERVOIR or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NE 1/4, SW 1/4 NE 1/4, SECTION 4, T 4 N, R 29 E, W.M.; STREAM - 1040 FEET NORTH & 1540 FEET WEST FROM E1/4 CORNER SECTION 4; RESERVOIR - 1180 FEET SOUTH & 580 FEET WEST FROM NE CORNER SECTION 4.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. THE RIGHT SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
