confirms the right to use the waters of THOMAS WELL 1 AND OLSEN WELL 3 in the ZOLLNER CREEK BASIN for the purpose of IRRIGATING 93.3 ACRES.

The right has been perfected under Permit G-7584. The date of priority is MAY 19, 1977. The right is limited to not more than 1.17 CUBIC FEET PER SECOND; BEING 0.61 CFS FROM WELL 1 AND 0.56 CFS FROM WELL 3 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 43, SECTION 17,
 NW 1/4 NE 1/4, SECTION 19, T 6 S, R 1 E, W.M.; WELL 1 - 1110 FEET
 SOUTH & 80 FEET EAST FROM NW CORNER SECTION 17; WELL 3 - 560 FEET
 SOUTH & 3480 FEET EAST FROM NW CORNER SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
