CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ROLLIN AND MYRTLE BEAVER  
8930 OLD FORT ROAD  
INDEPENDENCE, OREGON 97351

confirms the right to use the waters of AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-6612, a tributary TO LUCKIAMUTE RIVER, for the purpose of SUPPLEMENTAL IRRIGATION OF 24.4 ACRES.

The right has been perfected under Permit 41796. The date of priority is FEBRUARY 25, 1977. The right is limited to not more than 0.22 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 61, SECTION 17,  
T 9 S, R 4 W, W.M.; 2140 FEET NORTH & 40 FEET EAST FROM SE CORNER OF  
DLC 61.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. THE RIGHT SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 SW 1/4 13.0 ACRES  
SW 1/4 SW 1/4 11.4 ACRES  
BOTH AS PROJECTED WITHIN DLC 61  
SECTION 17  
TOWNSHIP 9 SOUTH, RANGE 4 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
