## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LAVINA P. ARROWOOD BOX 196-A NORTH MYRTLE ROAD MYRTLE CREEK, OREGON 97457

confirms the right to use the waters of LITTLE LICK CREEK, AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-7816 AND FOUR SPRINGS, tributaries of NORTH MYRTLE CREEK, for the purpose of IRRIGATING 5.3 ACRES AND DOMESTIC USE FOR FOUR FAMILIES.

The right has been perfected under Permit 44075. The date of priority is MARCH 22, 1979. The right is limited to not more than 0.085 CUBIC FOOT PER SECOND; BEING 0.06 CFS FROM LITTLE LICK CREEK FOR IRRIGATION, 0.01 CFS FROM THE UNNAMED STREAM AND RESERVOIR FOR IRRIGATION, 0.01 CFS FROM SPRINGS #2 AND #3 FOR DOMESTIC USE FOR 3 FAMILIES, AND 0.005 FROM SPRINGS #4 & #5 FOR DOMESTIC USE FOR 1 FAMILY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NE 1/4, NE 1/4 NW 1/4, NW 1/4 NW 1/4, ALL AS PROJECTED WITHIN DLC 41; SW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 40; SW 1/4 NW 1/4, SECTION 18, T 29 S, R 4 W, W.M.; SPRING 4 - 980 FEET SOUTH AND 3110 FEET EAST; SPRING 5 - 1290 FEET SOUTH AND 2560 FEET EAST; SPRING 2 - 60 FEET SOUTH AND 1240 FEET EAST; SPRING 3 - 490 FEET SOUTH AND 960 FEET EAST; UNNAMED STREAM AND RESERVOIR - 1750 FEET SOUTH AND 3050 FEET EAST; LITTLE LICK CREEK - 1500 FEET SOUTH AND 680 FEET EAST, 2300 FEET SOUTH AND 620 FEET EAST; 2530 FEET SOUTH AND 660 FEET EAST; ALL FROM NW CORNER SECTION 18.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
