CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CITY OF REDMOND 455 SOUTH 7TH STREET REDMOND, OREGON 97756

confirms the right to use the waters of REDMOND MUNICIPAL SEWAGE TREATMENT PLANT, for the purpose of IRRIGATING 141.8 ACRES.

The right has been perfected under Permit 44101. The date of priority is MARCH 21, 1979. The right is limited to not more than 2.3 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 5, T 15 S, R 13 E, W.M.; 459.87 FEET SOUTH & 216.96 FEET WEST FROM NE CORNER SECTION 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
