CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

CITY OF REDMOND
455 SOUTH 7TH STREET
REDMOND, OREGON 97756

confirms the right to use the waters of SEWAGE EFFLUENT STORAGE RESERVOIR CONSTRUCTED UNDER PERMIT R-8336, for the purpose of THE SUPPLEMENTAL IRRIGATION OF 141.8 ACRES.

The right has been perfected under Permit 46323. The date of priority is MARCH 20, 1981. The right is limited to not more than 286.0 ACRE-FEET STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source. The point of diversion is located as follows:

SE 1/4 SW 1/4, SECTION 19, T 14 S, R 13 E, W.M.;
860.85 FEET NORTH & 693.61 FEET WEST FROM S1/4 CORNER SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 4.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. THE RIGHT SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
