CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DORIA L. AUDET

confirms the right to use the waters of PRAIRIE CREEK AND AN UNNAMED STREAM, tributaries of WALLOWA RIVER, for the purpose of IRRIGATING 139.0 ACRES.

The right has been perfected under Permit 41063. The date of priority is SEPTEMBER 2, 1976. The right is limited to not more than 1.44 CUBIC FEET PER SECOND; BEING 1.0 CFS FROM PRAIRIE CREEK AND 0.44 CFS FROM UNNAMED STREAM, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 10 (NW 1/4 SE 1/4), LOT 15 (SW 1/4 SE 1/4), SECTION 1, T 2 S, R 44 E, W.M.; PRAIRIE CREEK - 2060 FEET NORTH & 1890 FEET WEST; UNNAMED STREAM - 850 FEET NORTH & 2050 FEET WEST BOTH FROM SE CORNER SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

TOWNSHIP 2 SOUTH, RANGE 44 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
