confirms the right to use the waters of FOLEY GULCH AND AN UNNAMED SPRING STREAM, tributaries of COYOTE CREEK, for the purpose of DOMESTIC USE FOR THREE FAMILIES, IRRIGATING 1.4 ACRES, GREENHOUSE AND LABORATORY USE.

The right has been perfected under Permit 41653. The date of priority is MARCH 30, 1977. The right is limited to not more than 0.09 CUBIC FOOT PER SECOND; BEING 0.01 CFS FROM SPRING STREAM FOR DOMESTIC USE, 0.07 CFS FOR IRRIGATION, AND 0.005 CFS FOR GREENHOUSE AND 0.005 CFS FROM FOLEY GULCH FOR LABORATORY or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NE 1/4, NW 1/4 SE 1/4, SW 1/4 NE 1/4, SECTION 19,
T 33 S, R 5 W, W.M.; FOLEY GULCH - 4540 FEET NORTH & 100 FEET WEST,
2500 FEET NORTH & 2290 FEET WEST; SPRING STREAM - 3320 FEET NORTH &
2530 FEET WEST; ALL FROM SE CORNER SECTION 19.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4 1.2 ACRES, DOMESTIC, GREENHOUSE, LABORATORY
NW 1/4 NE 1/4 0.2 ACRE
SECTION 19
TOWNSHIP 33 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
