CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALLEN R. WISER ROUTE 1, BOX 43 MONROE, OREGON 97456

confirms the right to use the waters of LONG TOM RIVER AND FERN RIDGE RESERVOIR CONSTRUCTED UNDER PERMIT R-1625, a tributary of WILLAMETTE RIVER, for the purpose of IRRIGATING 55.3 ACRES.

The right has been perfected under Permit 42524. The date of priority is MARCH 25, 1977. The right is limited to not more than 0.69 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 33, T 14 S, R 5 W, W.M.; 1440 FEET NORTH & 30 FEET WEST FROM THE SE CORNER SECTION 33; RESERVOIR - NE 1/4 SW 1/4, SECTION 4, T 17 S, R 5 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year FROM DIRECT FLOW AND STORAGE FROM RESERVOIR CONSTRUCTED UNDER PERMIT NO. R-1625, AND IS SUBJECT TO THE TERMS AND CONDITIONS OF CONTRACT NO. 7-07-10-W0069, OR A SATISFACTORY REPLACEMENT, BETWEEN THE BUREAU OF RECLAMATION AND THE APPLICANT, A COPY OF WHICH IS ON FILE IN THE RECORDS OF THE WATER RESOURCES DEPARTMENT.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SE 1/4 18.5 ACRES NW 1/4 SE 1/4 2.2 ACRES SW 1/4 SE 1/4 0.8 ACRE SE 1/4 SE 1/4 10.3 ACRES SECTION 33

NW 1/4 SW 1/4 0.2 ACRE SW 1/4 SW 1/4 21.3 ACRES SE 1/4 SW 1/4 2.0 ACRES

SECTION 34

TOWNSHIP 14 SOUTH, RANGE 5 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
