CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

LAVERN AND CARMELITA MILLER 5058 BOOTH HILL ROAD HOOD RIVER, OREGON 97031

confirms the right to use the waters of A SPRING & AN UNNAMED STREAM, a tributary TO NEAL CREEK, for the purpose of DOMESTIC USE FOR ONE FAMILY AND SUPPLEMENTAL IRRIGATION OF 11.0 ACRES.

The right has been perfected under Permit 46732. The date of priority is MARCH 1, 1982. The right is limited to not more than 0.13 CUBIC FOOT PER SECOND, BEING 0.005 CFS FOR DOMESTIC FROM SPRING AND 0.125 CFS FOR SUPPLEMENTAL IRRIGATION FROM STREAM or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, SECTION 11, T 1 N, R 10 E, W.M.; SPRING - 860 FEET NORTH & 1160 FEET EAST; STREAM - 1070 FEET NORTH & 1200 FEET EAST BOTH FROM SW CORNER SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. THE RIGHT SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 SW 1/4 2.9 ACRES AND DOMESTIC SE 1/4 SW 1/4 8.1 ACRES SECTION 11
TOWNSHIP 1 NORTH, RANGE 10 EAST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
