CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That T. H. LAFOLLETTE and B. F. ALLEN of Prineville State of Oregon has a right to the use of the waters of Ochoco Creek, a tributary of Crooked River

for the purpose of the irrigation of 594.3 acres of land, and stock and domestic use.

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 1, at page 449 ; that the priority of the right hereby confirmed dates from the year 1864 for the irrigation of 79.7 acres in Tract No. 1; from 1903 for the irrigation of 119.6 acres in Tract No. 1; from 1873 for the irrigation of Tract No. 2; and from July 8, 1909, for the irrigation of Tract No. 3:

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a reasonable amount for domestic and stock use, and 7.21 cubic feet per second for irrigation, the total quantity being limited to four acre feet per acre during each year. The use hereunder shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

199.3 acres in Tract No. 1, located as follows: 25 acres in the NE 1/4 of NW 1/4; 20.1 acres in the NW 1/4 of NW 1/4; 6 acres in the SW 1/4 of NW 1/4; Section Twenty-three (23): 7.9 acres in the NE 1/4 of NE 1/4; 22.1 acres in the SW 1/4 of NE 1/4; 31.1 acres in the SE 1/4 of NE 1/4; 2.9 acres in the SW 1/4 of NW 1/4; 7 acres in the SE 1/4 of NW 1/4; 29.1 acres in the NE 1/4 of SW 1/4; 30 acres in the NW 1/4 of SW 1/4; 18.1 acres in the NW 1/4 of SE 1/4; Section Twenty-two (22), Township Fourteen (14) South Range Eighteen (18) East of Willamette Meridian, in Crook County, Oregon.

134.5 acres in Tract No. 2, located as follows: 2 1/2 acres in the NE 1/4 of SW 1/4; 4 acres in the NW 1/4 of SW 1/4; 40 acres in the SW 1/4 of SW 1/4; 38 acres in the SE 1/4 of SW 1/4; 35 acres in the SW 1/4 of SE 1/4; 15 acres in the SE 1/4 of SE 1/4; Section Thirty-six (36), Township Fourteen (14) South Range Sixteen (16) East of Willamette Meridian, in Crook County, Oregon.

261 acres in Tract No. 3, located as follows: 25 acres in the NW 1/4 of NE 1/4; 20 acres in the NE 1/4 of NW 1/4; 32 acres in the NW 1/4 of NW 1/4; 40 acres in the SW 1/4 of NW 1/4; 39 acres in the SE 1/4 of NW 1/4; 40 acres in the NE 1/4 of SW 1/4; 35 acres in the NW 1/4 of SW 1/4; 30 acres in the NW 1/4 of SE 1/4; Section Thirty-six (36), Township Fourteen (14) South Range Sixteen (16) East of Willamette Meridian, in Crook County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
