CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of A WELL in the LITTLE PUDDING RIVER BASIN for the purpose of IRRIGATING 86.0 ACRES.

The right has been perfected under Permit G-1670. The date of priority is SEPTEMBER 15, 1960. The right is limited to not more than 0.67 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

NW 1/4 NE 1/4, AS PROJECTED WITHIN DLC 57, SECTION 11,
T 7 S, R 2 W, W.M.; 3630 FEET NORTH & 270 FEET EAST FROM SW CORNER OF
DLC 57.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
