CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JACK D. FROST
ROUTE 1, BOX 151
YAMHILL, OREGON 97148

confirms the right to use the waters of NORTH YAMHILL RIVER, a tributary of YAMHILL RIVER, for the purpose of IRRIGATING 17.2 ACRES AND STOCK.

The right has been perfected under Permit 13891. The date of priority is JUNE 27, 1939. The right is limited to not more than 0.28 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL DIVERSION POINT; BEING 0.22 CFS FOR IRRIGATION AND 0.06 CFS FOR STOCK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 41, SECTION 5, T 3 S, R 4 W, W.M.; STOCK, 1620 FEET NORTH & 630 FEET EAST, IRRIGATION, 1630 FEET NORTH & 830 FEET EAST, BOTH FROM THE SW CORNER OF SECTION 5.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

his certificate is issued to confirm a change in USE AND POINT OF DIVERSION approved by orders of the Water Resources Director entered FEBRUARY 15, 1974, AND OCTOBER 9, 1979, and supersedes certificate 15582, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
