## RIGHT WAILR CERTIFICATE

(For Rights which have been confirmed by the Courts)

This is to Certify, That

has a right to the use of

the waters of Wolf and Ochoco Creeks, tributary to Crooked River

for the purpose of the irrigation of 152 acres of land, and stock and domestic use,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Crook County, and the said decree entered of record at Salem, in the Order Record of the Research of the Research of the State of Oregon, in Volume 1, at 3449 ; that the priority of the right hereby confirmed dates from the year 1872 for the irrigation of Tract No.1, with the waters of Wolf Creek; from 1885 for the irrigation of 51 acres in Tract No.2 from Ochoco Creek; from 1895 for the irrigation of acres in Tract 2 from Ochoco Creek; from 1892 for 90 acres in Tract 3, from Ochoco that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a reasonable amount for domestic and stock purposes, and 1.99 cubic feet per second for irrigation, the total cuantity being limited to four acre feet per acre during each year. The use hereunder shall conform to any reasonable rotation system ordered by the proper state officer.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows:

in Tract No. 1, located as follows: 4 acres in the NE4 of NW4; Section Twenty-four (24), Township Fourteen (14) South Range Eighteen (18) East of Willamette Meridian, in Crook County, Oregon.

58 acres in Tract No. 2, located as follows: 28 acres in the NE1 of NE1; Section Twenty-three (23) 30 acres in the NW1 of NW1; Section Twenty-four (24): all in Township Fourteen (14) South Range Eighteen (18) East of Willamette Meridian, in Crook County, Oregon.

90 acres in Tract No. 3, located as follows: 12 acres in the NE $_4^1$  of SW $_4^1$ ; 20 acres in the SW $_4^1$  of SW $_4^1$ ; 29 acres in the SE $_4^1$ ; 20 acres in the NW $_4^1$  of SE $_4^1$ ; 9 acres in the SW $_4^1$  of SE $_4^1$ ; Section Thirteen (13), Township Fourteen (14) South Range Eighteen (18) East of Willamette Meridian, in Crook County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described. State
