CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HEMEN-WAY FARMS  
80254 SEARS ROAD  
COTTAGE GROVE, OREGON 97424

confirms the right to use the waters of WATERHOUSE SLOUGH, SNOW SLOUGH AND GIDDINGS CREEK, tributaries of WILLAMETTE RIVER, for the purpose of IRRIGATING 65.6 ACRES.

The right has been perfected under Permit 22440. The date of priority is MARCH 18, 1953. The right is limited to not more than 0.635 CUBIC FOOT PER SECOND, BEING 0.28 CFS FROM WATERHOUSE SLOUGH, 0.08 CFS FROM SNOW SLOUGH AND 0.275 CFS FROM GIDDINGS CREEK or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 3 (SE 1/4 NW 1/4), NW 1/4 SW 1/4, NE 1/4 SW 1/4, BOTH AS PROJECTED WITHIN J. SOUTHWELL DLC 46, SE 1/4 NW 1/4, AS PROJECTED WITHIN R. CLARKE DLC 47, SECTION 11, T 20 S, R 3 W, W.M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate describes that portion of the water right confirmed by certificate 23791, State Record of Water Right Certificates, NOT modified by the provisions of an order of the Water Resources Director entered SEPTEMBER 26, 1988, approving transfer application 6127.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
