CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

WARREN AND LEILA ALLEN  
611 NW BRIDGE STREET  
JOHN DAY, OREGON 97845

confirms the right to use the waters of JOHN DAY RIVER, a tributary of COLUMBIA RIVER, for the purpose of IRRIGATING 0.34 ACRE.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for GRANT County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 15, at page 461. The date of priority is 1892.

The right is limited to not more than 0.01 CUBIC FOOT PER SECOND AND ONE ACRE-FOOT PER ACRE PER CALENDAR MONTH TO JULY 1 AND 3/4 ACRE-FOOT PER ACRE THEREAFTER, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION; SW 1/4 SE 1/4, SECTION 23, T 13 S, R 31 E, W.M.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 23, T 13 S, R 31 E, W.M.; 324 FEET NORTH & 460 FEET EAST FROM THE SW CORNER OF NE 1/4 SW 1/4 SECTION 23.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year APRIL 1 TO SEPTEMBER 30.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SW 1/4 0.34 ACRE  
SECTION 23  
TOWNSHIP 13 SOUTH, RANGE 31 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered DECEMBER 4, 1979, and together with certificate 48957, supersedes certificate 25411, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
