CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

JAMES L. SCHEFFEL 239 COOK AVENUE ANCHORAGE, ALASKA

confirms the right to use the waters of WOOLFOLK RESERVOIR CONSTRUCTED UNDER PERMIT R-1662, a tributary of LITTLE BUTTE CREEK, for the purpose of IRRIGATING 35.4 ACRES.

The right has been perfected under Permit 23116. The date of priority is JUNE 1, 1954. The right is limited to not more than 175.5 ACRE FEET OF STORED WATER ONLY or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SW 1/4 SW 1/4, SECTION 34, T 35 S, R 1 E, W.M.; 700 FEET NORTH & 280 FEET EAST FROM THE SW CORNER SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 4.5 acre feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in USE approved by an order of the Water Resources Director entered SEPTEMBER 5, 1978, and together with certificate 46569, supersedes certificate 41765, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
