## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

EARL F. ROBISON 15540 S.W. BEEF BEND ROAD TIGARD, OREGON 97223

confirms the right to use the waters of AN UNNAMED STREAM AND RESERVOIR CONSTRUCTED UNDER PERMIT R-7675, a tributary TO TUALATIN RIVER, for the purpose of MAINTENANCE OF A FIRE PROTECTION SYSTEM, AND IRRIGATING 2.0 ACRES.

The right has been perfected under Permit 43310. The date of priority is AUGUST 3, 1978. The right is limited to not more than 0.04 CUBIC FOOT PER SECOND; BEING 0.01 CFS FOR MAINTENANCE OF A PROTECTION SYSTEM AND 0.03 CFS FOR IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NW 1/4 SE 1/4, SECTION 17, T 2 S, R 1 W, W.M.; STREAM - 20 FEET SOUTH & 810 FEET EAST; RESERVOIR - 150 FEET SOUTH & 650 FEET EAST, BOTH FROM C1/4 CORNER SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. WATER SHALL NOT BE APPROPRIATED DURING THE PERIOD FROM JULY 31 THROUGH SEPTEMBER 15 OF EACH YEAR, EXCEPT FOR STORED WATER.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4 1.5 ACRES AND FIRE PROTECTION NW 1/4 SE 1/4 0.5 ACRE SECTION 17
TOWNSHIP 2 SOUTH, RANGE 1 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
