CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

RICHARD VON

CARLTON, OREGON 97111

confirms the right to use the waters of PANTHER CREEK, AN UNNAMED STREAM AND VON RESERVOIR CONSTRUCTED UNDER PERMIT R-8152, a tributary of NORTH YAMHILL RIVER, for the purpose of IRRIGATING 5.0 ACRES AND SUPPLEMENTAL IRRIGATION OF 45.0 ACRES.

The right has been perfected under Permit 44950. The date of priority is JUNE 20, 1980. The right is limited to not more than 0.56 CUBIC FOOT PER SECOND, BEING 0.06 CFS FROM PANTHER CREEK WITH ANY DEFICIENCY IN THE SUPPLY TO BE APPROPRIATED FROM AN UNNAMED STREAM & VON RESERVOIR FOR PRIMARY IRRIGATION AND 0.5 CFS FROM UNNAMED STREAM AND RESERVOIR FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 SE 1/4, SECTION 21, NW 1/4 SW 1/4, SECTION 22, BOTH AS PROJECTED WITHIN DLC 46, T 3 S, R 5 W, W.M.; UNNAMED STREAM AND RESERVOIR - 2020 FEET NORTH & 770 FEET WEST; PANTHER CREEK - 1500 FEET NORTH AND 125 FEET EAST; BOTH FROM SE CORNER SECTION 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage. THE RIGHT SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
