CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HENRY STEELE
ROUTE 1, BOX 125
HAINES, OREGON 97833

confirms the right to use the waters of TWO SUMP WELLS in the POWDER RIVER BASIN for the purpose of THE SUPPLEMENTAL IRRIGATION OF 273.0 ACRES.

The right has been perfected under Permit G-8449. The date of priority is NOVEMBER 28, 1978. The right is limited to not more than 3.41 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the sump wells.

The sump wells are located as follows:

SE 1/4 SW 1/4, SECTION 28, NE 1/4 NW 1/4, SECTION 33, T 7 S, R 39 E, W.M.; 80 FEET NORTH AND 510 FEET WEST, 850 FEET SOUTH AND 40 WEST BOTH FROM S 1/4 CORNER SECTION 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein, and shall be further limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
