confirms the right to use the waters of LITTLE RUSSEL CREEK AND GOODIN CREEK, tributaries of WAPATO CREEK, for the purpose of IRRIGATING 93.5 ACRES.

The right has been perfected under Permit 40427. The date of priority is MARCH 23, 1976. The right is limited to not more than 1.17 CUBIC FEET PER SECOND; BEING 0.2 CFS FROM LITTLE RUSSEL CREEK AND 0.97 CFS FROM GOODIN CREEK, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NE 1/4, NW 1/4 NW 1/4, AS PROJECTED WITHIN DLC 56, SECTION 11, T 2 S, R 4 W, W.M.; LITTLE RUSSEL CREEK - 600 FEET SOUTH & 100 FEET EAST, 720 FEET SOUTH & 410 FEET EAST; GOODIN CREEK - 550 FEET SOUTH & 5150 FEET EAST; 350 FEET SOUTH & 5240 FEET EAST; ALL FROM THE NW CORNER SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
