CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SHERMAN E. HAWKINS
ROUTE 2, BOX 2660
LAGRANDE, OREGON 97850

confirms the right to use the waters of LITTLE CREEK AND CATHERINE CREEK, tributaries of THE GRANDE RONDE RIVER, for the purpose of THE PRIMARY AND SUPPLEMENTAL IRRIGATION OF 18.64 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for UNION County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 8, at page 1. The date of priority is 1891 FROM LITTLE CREEK FOR PRIMARY IRRIGATION AND 1905 FROM CATHERINE CREEK FOR SUPPLEMENTAL IRRIGATION.

The right is limited to not more than THREE ACRE FEET PER ACRE IN ANY IRRIGATION SEASON, DIVERTED AT A RATE OF NOT TO EXCEED ONE-FORTHIETH OF A CUBIC FOOT PER SECOND PER ACRE, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION; HEMPE-WRIGHT-HUTCHINSON DITCH.

The points of diversion are located as follows:

SE 1/4 SE 1/4, SECTION 13, T 4 S, R 39 E, W.M.; NE 1/4 NE 1/4, SECTION 19, T 4 S, R 40 E, W.M.; LITTLE CREEK - DOBBIN DITCH, CATHERINE CREEK - SWACKHAMMER DITCH, 60 FEET SOUTH AND 1150 FEET WEST FROM NE CORNER SECTION 19.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 NE 1/4 18.64 ACRES
SECTION 12
TOWNSHIP 4 SOUTH, RANGE 39 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered JANUARY 28, 1980, and together with certificates 49084 AND 60398, supersedes certificate 6644, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
