CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That c. m. LISTER

for the purpose of the irrigation of 150 acres of land, and stock and domestic use

that the amount of water to which such right is entitled and hereby confirmed for the purpose saforesaid, is limited to an amount actually beneficially used for said purpose s, and shall not exceed a reasonable amount for domestic and stock use, and 1.88 cubic feet per second for irrigation, the total quantity being limited to four acre feet per acre during each year. The use hereunder shall conform to any reasonable rotation system ordered by the proper state officer.
