CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of LITTLE BUTTE CREEK, a tributary of ROGUE RIVER, for the purpose of IRRIGATING 20.0 ACRES.

The right has been perfected under Permit 21122. The date of priority is DECEMBER 12, 1951. The right is limited to not more than 0.25 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION: LOT 2 (NW 1/4 NE 1/4), SECTION 8, T 36 S, R 1 W, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

SE 1/4 NW 1/4, AS PROJECTED WITHIN STOW DLC 51, SECTION 8, T 36 S, R 1 W, W.M.; 1920 FEET SOUTH AND 1220 FEET WEST FROM THE C1/4 CORNER SECTION 8.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 4.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, and is subject to the terms and conditions of a stipulation recorded at pages 642-643, Volume 3, Misc. Records of the Water Resources Director, and by reference is made a part hereof.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 SW 1/4 20.0 ACRES  
SECTION 8  
TOWNSHIP 36 SOUTH, RANGE 1 WEST, W.M.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered SEPTEMBER 22, 1977, and together with certificate 44955, supersedes certificate 27966, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
