CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KENNETH M. ERREND 1908 JUPITER WAY LAGRANDE, OREGON 97850

confirms the right to use the waters of BEAVER CREEK, a tributary of POWDER RIVER, for the purpose of IRRIGATING 37.5 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for BAKER County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 6, at page 291. The date of priority is JANUARY 21, 1873 FOR TRACT 1, 1889 FOR TRACT 2, AND 1898 FOR TRACT 3.

The right is limited to not more than 0.94 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINTS OF DIVERSION; GARD DITCH 1, NE 1/4 NW 1/4, SECTION 21 AND GARD DITCH 2, NE 1/4 SE 1/4, SECTION 17, T 10 S, R 40 E, W.M.

The point of diversion is located as follows:

SE 1/4 SE 1/4, SECTION 17, T 10 S, R 40 E, W.M.; 1020 FEET NORTH AND 460 FEET WEST FROM SE CORNER OF SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
