CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of A DRILLED WELL AND A SUMP WELL in the ROGUE RIVER BASIN for the purpose of IRRIGATING 80.8 ACRES.

The right has been perfected under Permit G-6479. The date of priority is JUNE 4, 1975. The right is limited to not more than 1.01 CUBIC FEET PER SECOND, BEING; 0.75 CFS FROM THE DRILLED WELL AND 0.26 CFS FROM THE SUMP WELL, or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 39, SECTION 36, T 35 S, R 7 W, W.M.; WELL - 1720 FEET NORTH AND 1070 FEET EAST, SUMP-2500 FEET NORTH AND 1160 FEET EAST, BOTH FROM SW CORNER SECTION 36.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NE 1/4	2.5 ACRES
SW 1/4 NW 1/4	3.0 ACRES
SE 1/4 NW 1/4	12.0 ACRES
NE 1/4 SW 1/4	38.0 ACRES
NW 1/4 SW 1/4	13.0 ACRES
SE 1/4 SW 1/4	6.0 ACRES
NW 1/4 SE 1/4	6.3 ACRES

ALL AS PROJECTED WITHIN DLC 39  
SECTION 36  
TOWNSHIP 35 SOUTH, RANGE 7 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
