CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

MELVIN DURETTE
ROUTE 2, BOX 1525
MADRAS, OREGON 97741

confirms the right to use the waters of PINE HOLLOW CREEK, a tributary of WHITE RIVER, for the purpose of PRIMARY IRRIGATION OF 10.8 ACRES AND SUPPLEMENTAL IRRIGATION OF 131.8 ACRES.

The right has been perfected under Permit 43524. The date of priority is FEBRUARY 28, 1977. The right is limited to not more than 2.4 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NW 1/4, NW 1/4 NW 1/4, SECTION 11, T 4 S, R 12 E, W.M.; 1140 FEET SOUTH AND 1910 FEET EAST, 940 FEET SOUTH AND 900 FEET EAST, BOTH FROM THE NW CORNER, SECTION 11.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
