## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

SIDNEY T. AND PAULINE A. GOBEL ROUTE 2, BOX 77 BANKS, OREGON 97106

confirms the right to use the waters of AN UNNAMED STREAM, RESERVOIR CONSTRUCTED UNDER PERMIT R-8482 AND BLEDSOE CREEK, tributaries of EAST FORK DAIRY CREEK, for the purpose of WILDLIFE ATTRACTION.

The right has been perfected under Permit 46940. The date of priority is DECEMBER 4, 1978. The right is limited to not more than 0.10 CUBIC FOOT PER SECOND FROM STREAM WHEN AVAILABLE WITH ANY DEFICIENCIES IN THE AVAILABLE SUPPLY FROM THE STREAM TO BE MADE UP BY APPROPRIATION FROM BLEDSOE CREEK PROVIDED THAT THE TOTAL QUANTITY DIVERTED FROM BOTH SHALL NOT EXCEED 0.1 CFS or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 NE 1/4, SE 1/4 NW 1/4, AS PROJECTED WITHIN DLC 37, SECTION 4, T 1 N, R 3 W, W.M.; BLEDSOE CREEK POD #1 - 1050 FEET SOUTH & 2140 FEET EAST; UNNAMED STREAM #2 - 770 FEET SOUTH AND 1360 FEET EAST; #3 -850 FEET SOUTH AND 1610 FEET EAST; #4 - 900 FEET SOUTH AND 1900 FEET EAST, ALL FROM SOUTHWEST CORNER DLC 76.

The appropriation of water under the right allowed herein for waterfowl attraction shall be limited to the period from October 1 to January 31 of each year and shall be subordinate and inferior to all future rights for beneficial consumptive use.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

W 1/2 NE 1/4 E 1/2 NW 1/4 BOTH AS PROJECTED WITHIN DLC 37 SECTION 4 TOWNSHIP 1 NORTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
