confirms the right to use the waters of CHAPMAN WELLS 1 AND 2 in the COLUMBIA RIVER BASIN for the purpose of IRRIGATING 143.6 ACRES.

The right has been perfected under Permit U-725. The date of priority is MAY 2, 1955. The right is limited to not more than 1.792 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

SE 1/4 NW 1/4, NW 1/4 SW 1/4, SECTION 28, T 4 N, R 27 E, W.M.; WELL 1 - 56 CHAINS NORTH & 21.5 CHAINS EAST, WELL 2 - 24.5 CHAINS NORTH & 19.5 CHAINS EAST, BOTH FROM SW CORNER OF SECTION 28.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
