CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of LITTLE APPLGATE RIVER, a tributary of APPLGATE RIVER, for the purpose of IRRIGATING 24.0 ACRES AND STOCK USE.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 4, at page 1. The date of priority is SEPTEMBER 1, 1857.

The right is limited to not more than 0.48 CUBIC FOOT PER SECOND.

The point of diversion is located as follows:

NE 1/4 NE 1/4, SECTION 14, T 39 S, R 3 W, W.M.; FARMERS DITCH, 350 FEET SOUTH AND 900 FEET WEST FROM NE CORNER OF SECTION 14.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
