CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of LITTLE BUTTE CREEK, a tributary of ROGUE RIVER, for the purpose of IRRIGATING 45.0 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 14, at page 498. The date of priority is APRIL, 1899, FOR TRACT 1 AND 1908, FOR TRACT 2.

The right is limited to not more than 0.76 CUBIC FOOT PER SECOND FOR TRACT 1 AND 0.30 CFS FOR TRACT 2, AS MEASURED AT THE POINT OF DIVERSION, FROM APRIL 1ST TO OCTOBER 1ST OF EACH YEAR.

The point of diversion is located as follows:

NW 1/4 NE 1/4, SECTION 8, T 36 S, R 1 W, W.M.; 357 FEET SOUTH AND 295 FEET EAST FROM N 1/4 CORNER OF SECTION 8.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

This certificate is issued to confirm a change in PLACE OF USE approved by an order of the Water Resources Director, AND TO CONFIRM THAT PORTION OF THE RIGHT NOT MODIFIED BY THE ORDER, entered SEPTEMBER 22, 1977, and supersedes certificate 31232, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
