CERTIFICATE OF WATER RIGHT

RONALD F. KASPER ROUTE 2, BOX 2235 BANDON, OREGON 97411

confirms the right to use the waters of A WELL AND THREE SUMPS in the COQUILLE RIVER BASIN for the purpose of IRRIGATION, TEMPERATURE CONTROL, AND FLOOD HARVESTING OF 5.4 ACRES OF CRANBERRIES.

The right has been perfected under Permit G-8007. The date of priority is JANUARY 19, 1978. The right is limited to not more than 0.70 CUBIC FOOT PER SECOND, BEING 0.14 CFS FOR IRRIGATION, 0.70 CFS FOR TEMPERATURE CONTROL, AND 0.27 CFS FOR FLOOD HARVESTING FROM THE WELL WHEN AVAILABLE WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM THE WELL TO BE MADE UP BY APPROPRIATION FROM THE THREE SUMPS PROVIDED THAT THE TOTAL QUANTITY DIVERTED FROM ALL SOURCES SHALL NOT EXCEED 0.70 CFS or its equivalent in case of rotation, measured at the well and sumps.

The well and sumps are located as follows:

SW 1/4 SW 1/4, SE 1/4 SW 1/4, SECTION 4, T 28 S, R 14 W, W.M.; WELL 1 - 4150 FEET SOUTH & 1185 FEET EAST, SUMP 2 - 4270 FEET SOUTH & 790 FEET EAST, SUMP 3 - 4215 FEET SOUTH AND 1170 FEET EAST, SUMP 4-4780 FEET SOUTH AND 1680 FEET EAST ALL FROM NW CORNER SECTION 4.

The amount of water used for irrigation of cranberries, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. For the irrigation of any other crop this right is limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right is limited to appropriation of water only to the extent that it does not impair or substantially interfere with existing surface water rights of others.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NW 1/4 SW 1/4 0.2 ACRE SW 1/4 SW 1/4 5.2 ACRES SECTION 4

TOWNSHIP 28 SOUTH, RANGE 14 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described.
