CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

ALAN OBERSINNER
7886 NORTH HOWELL ROAD
SILVERTON, OREGON 97381

confirms the right to use the waters of THE PUDDING RIVER, a tributary of WILLAMETTE RIVER, for the purpose of THE PRIMARY IRRIGATION OF 30.5 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 63.2 ACRES.

The right has been perfected under Permit 42999. The date of priority is APRIL 3, 1978. The right is limited to not more than 1.17 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 17, T 6 S, R 1 W, W.M.; 530 FEET SOUTH AND 5040 EAST FROM W 1/4 CORNER SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year, provided further that the right allowed herein shall be limited to any deficiency in the available supply of any prior right existing for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
