CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GREGORY J. WIECK CHICO ROUTE, BOX 43 ENTERPRISE, OREGON 97828

confirms the right to use the waters of TWO WELLS in the SWAMP CREEK BASIN for the purpose of THE PRIMARY IRRIGATION OF 64.5 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 69.6 ACRES.

The right has been perfected under Permit G-8729. The date of priority is AUGUST 20, 1979. The right is limited to not more than 1.28 CUBIC FEET PER SECOND BEING 0.15 CFS FROM OLD WELL AND 1.13 CFS FROM NEW WELL, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

SW 1/4 NW 1/4, NW 1/4 SW 1/4, SECTION 21, T 1 S, R 45 E, W.M.; OLD WELL - 1400 FEET SOUTH AND 700 FEET EAST FROM NW CORNER SECTION 21, NEW WELL - 1180 FEET SOUTH AND 1140 FEET EAST FROM W 1/4 CORNER SECTION 21.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 3.0 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
