CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

HUDSON BAY DISTRICT IMPROVEMENT COMPANY
618 NORTH MAIN
MILTON-FREEWATER, OREGON 97862

confirms the right to use the waters of THE LITTLE WALLA WALLA RIVER AND TUM-A-LUM RIVER, tributaries of WALLA WALLA RIVER, for the purpose of THE PRIMARY IRRIGATION OF 425.5 ACRES AND THE SUPPLEMENTAL IRRIGATION OF 70.8 ACRES.

The right has been perfected under Permit 32145. The date of priority is FEBRUARY 15, 1967. The right is limited to not more than 10.3 CUBIC FEET PER SECOND WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM LITTLE WALLA WALLA RIVER TO BE MADE UP BY APPROPRIATION FROM TUM-A-LUM RIVER PROVIDED THE TOTAL QUANTITY DIVERTED FROM BOTH SOURCES DOES NOT EXCEED 10.3 CFS or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NE 1/4, SECTION 2, NE 1/4 NW 1/4, SECTION 1, T 5 N, R 35 E, W.M.; LITTLE WALLA WALLA-920 FEET SOUTH AND 310 WEST FROM NE CORNER SECTION 2, TUM-A-LUM-880 FEET SOUTH AND 740 WEST FROM N 1/4 CORNER SECTION 1.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to 0.0375 of one cubic foot per second per acre, or its equivalent for each acre irrigated. THE RIGHT ALLOWED HEREIN SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT EXISTING FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN, PROVIDED FURTHER THAT THE RIGHT ACQUIRED HEREIN TOGETHER WITH THAT UNDER ALL OTHER RIGHTS HELD BY THE COMPANY TO THE USE OF THE LITTLE WALLA WALLA AND TUM-A-LUM RIVERS SHALL NOT EXCEED THE CAPACITY OF THE DIVERSION WORKS AT TIME OF MAKING PROOF OF APPROPRIATION.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
