## CERTIFICATE OF WATER RIGHT

This is to Certify, That Mortgage Company for America

of Portland, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

a tributary of Trout Creek for the purpose of Irrigation & Domestic under Permit No. 409 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 1, 1909;

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed

**3.79 cubic feet per second;**

The use hereunder for irrigation shall conform to such reasonable rotation system as may be ordered by the proper state officer.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent in case of rotation.

A description of the lands irrigated under the right hereby confirmed, and to which such right is appurtenant (or, if for other purposes, the place where the water is put to beneficial use), is as follows: 10 acres in the  $W\frac{1}{2}SE\frac{1}{2}SE\frac{1}{4}$ , and 20 acres in the  $E\frac{1}{2}SE\frac{1}{2}SE\frac{1}{4}$  of Section Thirty-six (36), Township Thirty-nine South, Range Thirty-five East; 39.59 acres in the  $NW\frac{1}{2}NW\frac{1}{2}$  (Lot 1), 19.56 acres in the  $SW\frac{1}{2}NW\frac{1}{2}$  (Lot 2), 22.7 acres in the  $SE\frac{1}{2}NW\frac{1}{2}$ , and 19.52 acres in the  $NW\frac{1}{2}SW\frac{1}{2}$  (Lot 3) of Section Nineteen (19), Township Thirty-nine South, Range Thirty-six East; 40 acres in the  $SW\frac{1}{2}SW\frac{1}{2}$ , and 40.05 acres in the  $SE\frac{1}{2}SW\frac{1}{2}$  (Lot 4) of Section Thirty-one, Township Thirty-nine South, Range Thirty-six East; 40 acres in the  $NE\frac{1}{2}NE\frac{1}{2}$  of Section One (1), Township Forty South, Range Thirty-five East; 43.04 acres in the  $NW\frac{1}{2}NW\frac{1}{2}$  (Lot 4) of Section Six (6), Township Forty South, Range Thirty-six East of the Willamette Meridian, in Harney County, Oregon, being a total of 294.46 acres.

The right to the use of the water for irrigation purposes is restricted to the lands or place of use herein described.

Rights to the use of water for power purposes are limited to a period of forty years from the date of priority of the right, as herein set forth, subject to a preference right of renewal under the laws existing at the date of the expiration of the right for power purposes; as hereby confirmed and limited.
