# CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

FRANK AND MANUEL SILVA AND WESTERN RIDGE LAND COMPANY HC 82, BOX 230 KIMBERLY, OREGON 97848

confirms the right to use the waters of THE NORTH FORK JOHN DAY RIVER, a tributary of JOHN DAY RIVER, for the purpose of IRRIGATING 38.0 ACRES.

The right has been perfected under Permit 46922. The date of priority is JUNE 28, 1982, FOR 0.82 CFS AND AUGUST 4, 1982, FOR 0.13 CFS. The right is limited to not more than 0.95 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the points of diversion from the source.

The points of diversion are located as follows:

NE 1/4 NE 1/4, NW 1/4 NE 1/4, SECTION 8, NE 1/4 SE 1/4, SECTION 7, T 9 S, R 27 E, W.M.; 350 FEET SOUTH AND 1670 FEET EAST, 1000 FEET SOUTH AND 120 FEET EAST BOTH FROM N 1/4 CORNER SECTION 8, 170 FEET SOUTH AND 230 FEET WEST FROM E 1/4 CORNER SECTION 7.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
