## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

DONALD MOISAN 9155 WHEATLAND ROAD SALEM, OREGON 97303

confirms the right to the use of the waters of TWO WELLS in the WILLAMETTE RIVER BASIN for the purpose of IRRIGATING 62.8 ACRES.

The right has been perfected under Permit G-7565. The date of priority is NOVEMBER 7, 1977. The right is limited to not more than 0.80 CUBIC FOOT PER SECOND; BEING 0.49 CFS FROM WELL 1 AND 0.31 CFS FROM WELL 2 or its equivalent in case of rotation, measured at the well.

The wells are located as follows:

NW 1/4 SE 1/4, NE 1/4 SE 1/4, BOTH AS PROJECTED WITHIN DLC 60, SECTION 14, T 6 S, R 3 W, W.M.; WELL 1 - 830 FEET NORTH & 1400 FEET WEST; WELL 2 - 940 FEET NORTH & 300 FEET WEST BOTH FROM SE CORNER, DURBIN DLC 60.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
