## CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

STEVE GLASER P.O. BOX 257 TANGENT, OR 97389

confirms the right to use of the waters of GLASER WELL NO.1 in the CALAPOOIA RIVER BASIN for the purpose of IRRIGATING 105.1 ACRES.

The right has been perfected under Permit G-8858. The date of priority is OCTOBER 17, 1979. The right is limited to not more than 1.25 CUBIC FEET PER SECOND or its equivalent in case of rotation, measured at the well.

The well is located as follows:

SW 1/4 SW 1/4, AS PROJECTED WITHIN DLC 66, SECTION 34, T 11 S, R 4 W, W.M.; 170 FEET NORTH & 250 FEET EAST FROM SW CORNER SECTION 34.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
