confirms the right to use the waters of TWO WELLS in the SENECALE CREEK BASIN for the purpose of IRRIGATING 191.8 ACRES.

The right has been perfected under Permit G-8997. The date of priority is JANUARY 7, 1980. The right is limited to not more than 2.4 CUBIC FEET PER SECOND BEING 1.53 CFS FROM WELL 1 AND 0.87 CFS FROM WELL 2 or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

NE 1/4 NE 1/4, SE 1/4 NE 1/4, AS PROJECTED WITHIN DLC 61, SECTION 17, T 4 S, R 1 W, W.M.; WELL 1-1270 FEET SOUTH AND 600 FEET WEST, WELL 2-2450 FEET SOUTH AND 30 WEST BOTH FROM NE CORNER SECTION 17.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
