CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SHAW RESERVOIR, ENLARGED UNDER PERMIT R-5951, a tributary of CLOVER CREEK, for the purpose of SUPPLEMENTAL IRRIGATION OF 303.4 ACRES.

The right has been perfected under Permit 36717. The date of priority is MAY 1, 1973. The right is limited to not more than 307.0 ACRE FEET STORED WATER ONLY, or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NW 1/4 NW 1/4, SECTION 31, T 5 S, R 39 E, W.M.; 260 FEET SOUTH AND 4070 FEET WEST FROM NE CORNER SECTION 31.

THIS APPROPRIATION SHALL BE LIMITED TO A DIVERSION OF NOT MORE THAN 3.5 ACRE FEET PER ACRE FOR EACH ACRE IRRIGATED DURING THE IRRIGATION SEASON OF EACH YEAR. THE RIGHT ALLOWED HEREIN SHALL BE LIMITED TO ANY DEFICIENCY IN THE AVAILABLE SUPPLY OF ANY PRIOR RIGHT EXISTING FOR THE SAME LAND AND SHALL NOT EXCEED THE LIMITATION ALLOWED HEREIN.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.
