CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

KARL KROPP
ROUTE 2, BOX 398
CORNELIUS, OREGON 97113

confirms the right to use the waters of CHRISTENSEN CREEK, A SPRING, AND AN UNNAMED RESERVOIR CONSTRUCTED UNDER PERMIT R-7826, tributaries of TUALATIN RIVER, for the purpose of IRRIGATING 0.2 ACRE AND DOMESTIC USE FOR ONE FAMILY.

The right has been perfected under Permit 44145. The date of priority is MARCH 19, 1979. The right is limited to not more than 6 GALLONS PER MINUTE, BEING 4 GALLONS PER MINUTE FROM CHRISTENSEN CREEK AND THE RESERVOIR AND 1 GALLON PER MINUTE FROM THE SPRING FOR IRRIGATION, AND 1 GALLON PER MINUTE FROM THE SPRING FOR DOMESTIC USE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

SW 1/4 NE 1/4, SE 1/4 NE 1/4, SECTION 33, T 1 S, R 3 W, W.M.; SPRING - 570 FEET SOUTH AND 40 FEET WEST, CREEK & RESERVOIR- 310 FEET SOUTH AND 510 FEET EAST, BOTH FROM NW CORNER, SE 1/4 NE 1/4, SECTION 33.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated from direct flow and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year from direct flow and storage.

Water shall not be appropriated from direct flow during the period from JULY 31 through SEPTEMBER 15 of each year except for human consumption. Stored water may be used at any time.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SE 1/4 NE 1/4 0.2 ACRE AND DOMESTIC
SECTION 33
TOWNSHIP 1 SOUTH, RANGE 3 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
