CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of JOHN DAY RIVER, a tributary of COLUMBIA RIVER, for the purpose of IRRIGATING 12.7 ACRES.

The right has been perfected under Permit 24883. The date of priority is MAY 15, 1957. The right is limited to not more than 0.32 CUBIC FOOT PER SECOND or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 5 (SW 1/4 NW 1/4), SECTION 6, SE 1/4 NE 1/4 AND NW 1/4 SE 1/4, SECTION 7, T 11 S, R 26 E, W.M.; DIV 3 - 3410 FEET NORTH AND 1810 FEET WEST, DIV 4 - 3360 FEET NORTH AND 1720 FEET WEST, BALES DITCH - 2170 FEET SOUTH AND 1360 FEET EAST, MORRISON DITCH - 3600 FEET SOUTH AND 420 FEET EAST, ALL FROM THE SOUTH 1/4 CORNER, SECTION 6.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-FORTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 5.0 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:]

LOT 5 (SW 1/4 NW 1/4) 9.5 ACRES
SE 1/4 NW 1/4 1.5 ACRES
NE 1/4 SW 1/4 1.4 ACRES
LOT 6 (NW 1/4 SW 1/4) 0.3 ACRE
SECTION 6
TOWNSHIP 11 SOUTH, RANGE 26 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION approved by an order of the Water Resources Director entered MARCH 31, 1983, and together with certificate 51573, supersedes certificate 30274, State Record of Water Right Certificates. The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
