confirms the right to use the waters of DRY CREEK, a tributary of PINE CREEK, for the purpose of IRRIGATING 23.4 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 7, at page 148. The date of priority is 1882.

The right is limited to not more than 0.39 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION: STEEN DITCH, NE 1/4 NW 1/4, SECTION 35, T 5 N, R 35 E, W.M.

The points of diversion are located as follows:

PORTABLE PUMPING IN THE NE 1/4 NW 1/4, AND N 1/2 SE 1/4 NW 1/4, SECTION 26, T 5 N, R 35 E, W.M.; AND A DIVERSION IN THE S 1/2 SE 1/4 NW 1/4, SECTION 26, T 5 N, R 35 E, W.M.; 1810 FEET SOUTH & 1900 FEET EAST FROM NW CORNER SECTION 26.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-SIXTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed ONE ACRE FOOT PER ACRE DURING ANY THIRTY-DAY PERIOD, NOR THREE ACRE FEET PER ACRE DURING THE IRRIGATION SEASON BEGINNING APRIL 1ST AND ENDING OCTOBER 1ST.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
