CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

GLEN WEGNER, FELIX FLISCH, AND DAVID & ANITA WILLARD TLE APPLEGATE ROAD JACKSONVILLE, OREGON 97530

confirms the right to use the waters of LITTLE APPLEGATE RIVER, a tributary of APPLEGATE RIVER, for the purpose of IRRIGATING 7.4 ACRES.

The right has been perfected under Permit 9389. The date of priority is NOVEMBER 12, 1929. The right is limited to not more than 0.093 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION; GIN LIN DITCH, NW 1/4 NE 1/4, SECTION 29, T 39 S, R 2 W, W.M., or its equivalent in case of rotation, measured at the point of diversion from the source.

The point of diversion is located as follows:

NE 1/4 NW 1/4, SECTION 29, T 39 S, R 2 W, W.M.; UPPER PHILLIPS DITCH - 680 FEET SOUTH AND 9 FEET WEST FROM N1/4 CORNER, SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

SW 1/4 NW 1/4 1.2 ACRES SE 1/4 NW 1/4 5.7 ACRES NE 1/4 SW 1/4 0.5 ACRE

SECTION 19
TOWNSHIP 39 SOUTH, RANGE 2 WEST, W.M.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered NOVEMBER 3, 1980, and together with certificate 50142, supersedes certificate 24479, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
