CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of SCHWARTZ SPRING BRANCH, a tributary of PINE CREEK, for the purpose of IRRIGATING 39.5 ACRES.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for UMATILLA County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 7, at page 148. The date of priority is 1880.

The right is limited to not more than 0.49 CUBIC FOOT PER SECOND, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION: (HOON DITCH), NW 1/4 NE 1/4, SECTION 22, T 6 N, R 34 E, W.M.; 960 FEET SOUTH & 1055 FEET EAST FROM N1/4 CORNER SECTION 22.

The point of diversion is located as follows:

NE 1/4 SE 1/4, SECTION 16, T 6 N, R 34 E, W.M.; 1340 FEET NORTH AND 1230 FEET WEST FROM SE CORNER SECTION 16.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season of each year.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 NE 1/4 39.5 ACRES SECTION 21 TOWNSHIP 6 NORTH, RANGE 34 EAST, W.M.

This certificate is issued to confirm a change in POINT OF DIVERSION AND PLACE OF USE approved by an order of the Water Resources Director entered MARCH 17, 1978, and together with certificate 45582, supersedes certificate 5519, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
