CERTIFICATE OF WATER RIGHT

confirms the right to use the waters of SOUTH FORK COOS RIVER AND TWO UNNAMED STREAMS, a tributary of COOS RIVER, for the purpose of IRRIGATING 63.9 ACRES, STOCK WATERING AND DOMESTIC USE FOR ONE FAMILY.

The right has been perfected under Permit 48485. The date of priority is MAY 3, 1984. The right is limited to not more than 0.81 CUBIC FOOT PER SECOND BEING 0.80 CFS FROM SOUTH FORK COOS RIVER FOR IRRIGATION, 0.005 CFS FROM EACH UNNAMED STREAM FOR STOCK AND DOMESTIC USE, or its equivalent in case of rotation, measured at the point of diversion from the source.

The points of diversion are located as follows:

LOT 6 (SE 1/4 NE 1/4), SECTION 32, LOT 3 (SW 1/4 SE 1/4), SECTION 29, T 25 S, R 11 W, W.M.; RIVER - 2420 FEET SOUTH AND 410 FEET WEST, STREAM 1 - 540 FEET NORTH AND 1770 FEET WEST, STREAM 2 - 470 FEET NORTH AND 1700 FEET WEST ALL FROM SE CORNER SECTION 29.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

LOT 3 (SW 1/4 SE 1/4) 0.2 ACRE
SECTION 29

LOT 5 (NE 1/4 NE 1/4) 5.8 ACRES, STOCK & DOMESTIC
LOT 4 (NW 1/4 NE 1/4) 16.9 ACRES & STOCK
LOT 6 (SW 1/4 NE 1/4) 1.0 ACRE
LOT 6 (SE 1/4 NE 1/4) 22.2 ACRES & STOCK
SECTION 32

LOT 5 (SW 1/4 NW 1/4) 17.6 ACRES
LOT 5 (SE 1/4 NW 1/4) 0.2 ACRE
SECTION 33

TOWNSHIP 25 SOUTH, RANGE 11 WEST, W.M.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described. The right is subject to minimum flows established by the Water Resources Commission with an effective date prior to this right.
