confirms the right to use the waters of LITTLE BUTTE CREEK, a tributary of ROGUE RIVER, for the purpose of IRRIGATING 0.32 ACRE.

The right has been confirmed by decree of the Circuit Court of the State of Oregon for JACKSON County. The decree is of record at Salem, in the Order Record of the WATER RESOURCES DIRECTOR, in Volume 14, at page 498. The date of priority is 1883.

The right is limited to not more than 0.01 CUBIC FOOT PER SECOND FROM APRIL 1ST TO OCTOBER 1ST OF EACH YEAR, IF AVAILABLE AT THE ORIGINAL POINT OF DIVERSION; LITTLE BUTTE IRRIGATION COMPANY DITCH, SW 1/4 SE 1/4, SECTION 31, T 35 S, R 1 E, W.M.

The point of diversion is located as follows:

NE 1/4 SW 1/4, SECTION 3, T 36 S, R 1 W, W.M.; 1208 FEET SOUTH AND 645 FEET WEST FROM C 1/4 CORNER SECTION 3.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:

NE 1/4 SW 1/4 0.25 ACRES  
SE 1/4 SW 1/4 0.07 ACRES  
SECTION 3

TOWNSHIP 36 SOUTH, RANGE 1 WEST, W.M.

This certificate is issued to confirm a change in PLACE OF USE AND POINT OF DIVERSION approved by an order of the Water Resources Director entered JANUARY 27, 1978, and together with certificate 46183, supersedes certificate 38305, State Record of Water Right Certificates.

The issuance of this superseding certificate does not confirm the status of the water right in regard to the provisions of ORS 540.610 pertaining to forfeiture or abandonment.

The right to the use of the water for the above purpose is restricted to beneficial use on the lands or place of use described and shall be subject to all other conditions and limitations contained in said decree.
