CERTIFICATE OF WATER RIGHT

THIS CERTIFICATE ISSUED TO

confirms the right to use the waters of TWO WELLS, IN THE RYAN CREEK BASIN, for the purpose of PRIMARY IRRIGATION OF 38.1 ACRES AND SUPPLEMENTAL IRRIGATION OF 15.1 ACRES.

The right has been perfected under Permit G-8015. The date of priority is JANUARY 16, 1978. The right is limited to not more than 0.67 CUBIC FOOT PER SECOND; BEING 0.48 CFS FROM WELL 2 WITH ANY DEFICIENCY IN THE AVAILABLE SUPPLY FROM WELL 2 TO BE MADE UP BY WELL 1 FOR PRIMARY IRRIGATION, AND 0.19 CFS FROM WELL 2 FOR SUPPLEMENTAL IRRIGATION, or its equivalent in case of rotation, measured at the wells.

The wells are located as follows:

NE 1/4 NE 1/4, NW 1/4 NE 1/4, BOTH AS PROJECTED WITHIN DLC 48, SECTION 19, T 4 S, R 1 W, W.M.; WELL 1 - 1100 FEET SOUTH AND 2070 FEET EAST; WELL 2 - 1170 FEET SOUTH AND 1170 FEET EAST BOTH FROM THE NW CORNER OF DLC 48.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to ONE-EIGHTIETH of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2.5 acre-feet per acre for each acre irrigated during the irrigation season of each year. The right shall be limited to any deficiency in the available supply of any prior right for the same land and shall not exceed the limitation allowed herein.

The right shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right, and to which such right is appurtenant, is as follows:
